

Orland Park Church Car Ministry

Thank you for your contribution, as listed below, to the Car Ministry of the Orland Park Christian Reformed Church. This is a ministry of the deacons and volunteers of the Orland Park Christian Reformed Church, which has been granted 501(C) (3) status by the Internal Revenue Service. Contributions of goods are deductible for income tax purposes to the extent allowed by law. Please consult your tax advisor on how the tax laws allow you to deduct a specific value from your itemized Federal Income tax when you donate a vehicle to this ministry. The Orland Park Christian Reformed Church attests that no goods or services were given in return for this donation.

Please review the following details which will determine the specific value of your donation.

<u>Fair Market Value</u> - Unlike other non-profit and charity organizations, the Car Ministry of the Orland Park Christian Reformed Church distributes donated vehicles to needy families and individuals, after a safety inspection and necessary repairs are performed on the vehicle, and certain specific qualification requirements are met. If your vehicle donation is distributed to a needy family or individual, the Fair Market Value (Private Party Value) can be used on your Tax Return as found on the Kelly Blue Book Web Site at <u>www.kbb.com</u>. The Orland Park Christian Reformed Church does not fix an evaluation on your vehicle donation. That is the privilege and responsibility of the donor.

<u>Auction/Salvage Yard Value</u> – In some cases, after our safety inspection, it may be determined that the vehicle will not meet our requirements for safe and reliable transportation for a needy family and individual. In this situation your vehicle donation may be sold as-is at an auction or to a salvage yard and this sale value will be reported to you and will be required on your tax return. Your signature below acknowledges your understanding of this policy. The Orland Park Christian Reformed Church is required by law to notify you of the amount of auction or salvage yard sale.

<u>Private Party Sale Value</u> - In other cases a newer vehicle may not meet certain requirements for cost of ownership or practical use for our applicants, due to specific vehicle make or model. In this situation your vehicle may be sold to fund the ongoing expenses of this ministry. If your vehicle donation is sold to a private party, this value will be reported to you and will be required on your tax return. Your signature below acknowledges your understanding of this policy. The Orland Park Christian Reformed Church is required by law to notify you of the amount of private party sale.

It is our hope and desire that your vehicle donation will be passed on to a needy local family or individual in the name of Christ. All applicants to this ministry must meet specific qualifications requirements and are screened by our Car Ministry committee and Local Churches. Follow up is also done with the vehicle recipient as we feel this is an important part of the ministry.

Cash contributions are also accepted to this ministry. Thank you again for your generosity.
